1. Grant of Rights. I hereby grant to Photographer, his heirs, assigns and legal representatives, those for whom Photographer may represent, the absolute irrevocable right and permission to copyright in his own name or otherwise, and to use, re-use, publish, republish any and all pictures (digital, analog or otherwise) taken of me. Photographer may use such pictures in any media now existing or hereafter developed, including but not limited to print, digital, mobile and the Web. Photographer may use such pictures for any purpose whatsoever and for multiple purposes. Photographer is free to edit, crop, alter or change the pictures in any way he deems appropriate.

## 2. Consent.

- (a) I consent to the use of my name in connection with my pictures.
- (b) I consent to the use of any printed matter, advertising or other matter used in connection with my pictures.

## 3. Waivers.

- (a) I hereby waive any right that I may have to inspect or approve the finished product resulting from my pictures, how the pictures are used and any associated content or advertising copy.
- (b) I hereby waive the right to receive any additional compensation, royalty or fee for any use of my pictures.
- 4. Representations and Warranties. I hereby represent and warrant as follows:
  - (a) I fully understand and appreciate all of the terms and conditions of this release.
  - (b) I understand that this release is legally binding and not revocable by me.
  - (c) I am 21 years of age or older, or that if I am not at lest 21, then my parent or legal guardian is signing on my behalf at the end of this release.
- 5. <u>Indemnification & Hold Harmless</u>. I agree to indemnify, defend and hold harmless Photographer and his assigns, heirs, representatives (collectively "Indemnitees") and affiliate from and against any and all losses, claims, judgments, expenses, suits, damages, settlements, demands or liabilities of whatever kin or nature which Indemnitees may sustain or become subject to, arising out of relating to any breach of my representations, warranties or agreements contained herein. Such indemnification shall also include, without limitation,

- (d) If for any reason any provision or portion of this Agreement is found to be unenforceable, that provision or portion of the Agreement will be enforced to the maximum extent possible so as to affect the intent of the parties, and the remainder of this Agreement will continue in full force and effect.
- (e) The persons executing this Agreement are duly authorized to sign this Agreement on behalf of their company.
- (f) The parties to this Agreement are independent contractors. Neither party is an agent, representative, or partner of the other party.
